Service will be automatically renewed unless a written termination request from the customer is received by Massachusetts Electric at least 30 days prior to the end of the Service Term.

The customer acknowledges that the monthly/quarterly billing charges listed above are determined pursuant to the Optional Interval Data Service tariff approved by the Massachusetts Department of Telecommunications and Energy (DTE). The Optional Interval Data Service tariff may change from time to time, but any changes must be approved by the DTE. In the event that the fees reflected in the tariff are changed, Massachusetts Electric will notify the customer of the new fees that will be in effect at the beginning of the next Service Term, but will continue to bill the monthly/quarterly billing charges listed above until the completion of the current Service Term. If Massachusetts Electric does not receive a written termination request from the customer at least 30 days prior to the end of the current Service Term then, beginning with the next Service Term, Massachusetts Electric will bill and the customer agrees to pay the new monthly/quarterly billing charges, determined pursuant to the new total annual charge approved by the DTE.

Massachusetts Electric agrees to provide access to interval data through an Internet account that is available for the customer's use. The availability of this service will be subject to Massachusetts Electric's ability to render such service.
