# Transmission Network Operations

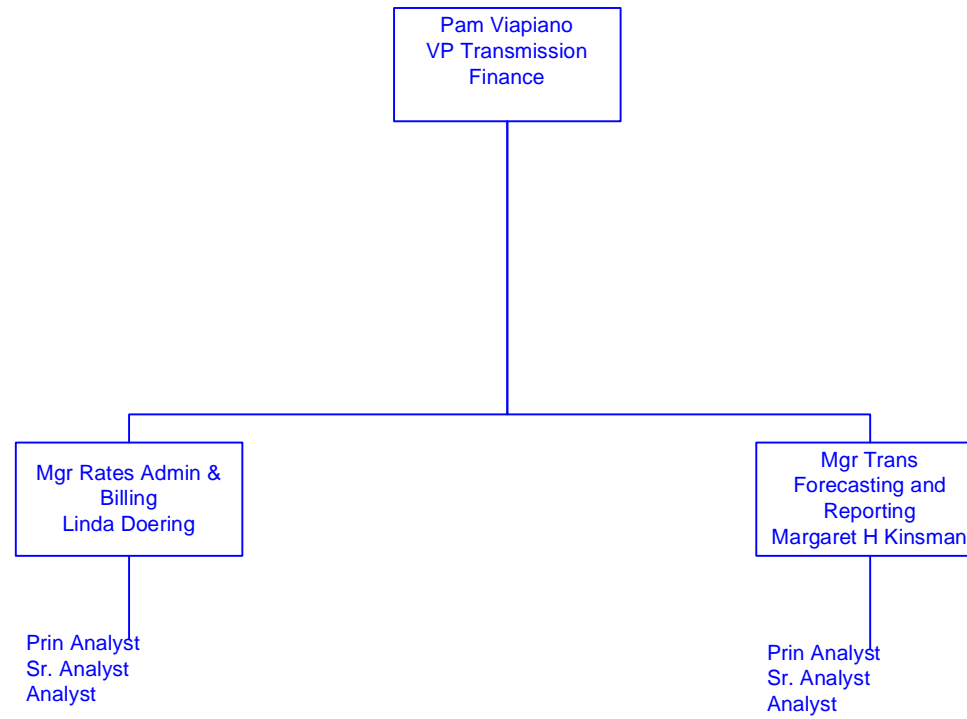

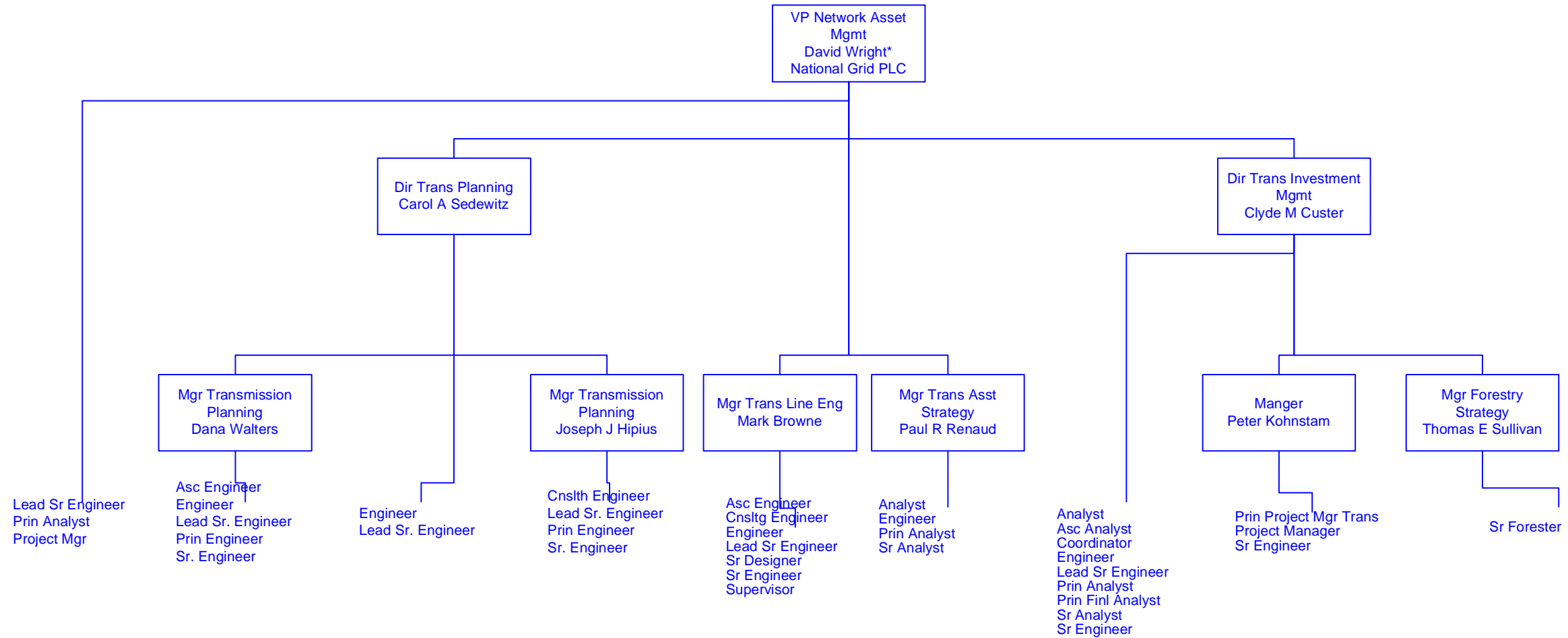

Transmission Asset Management

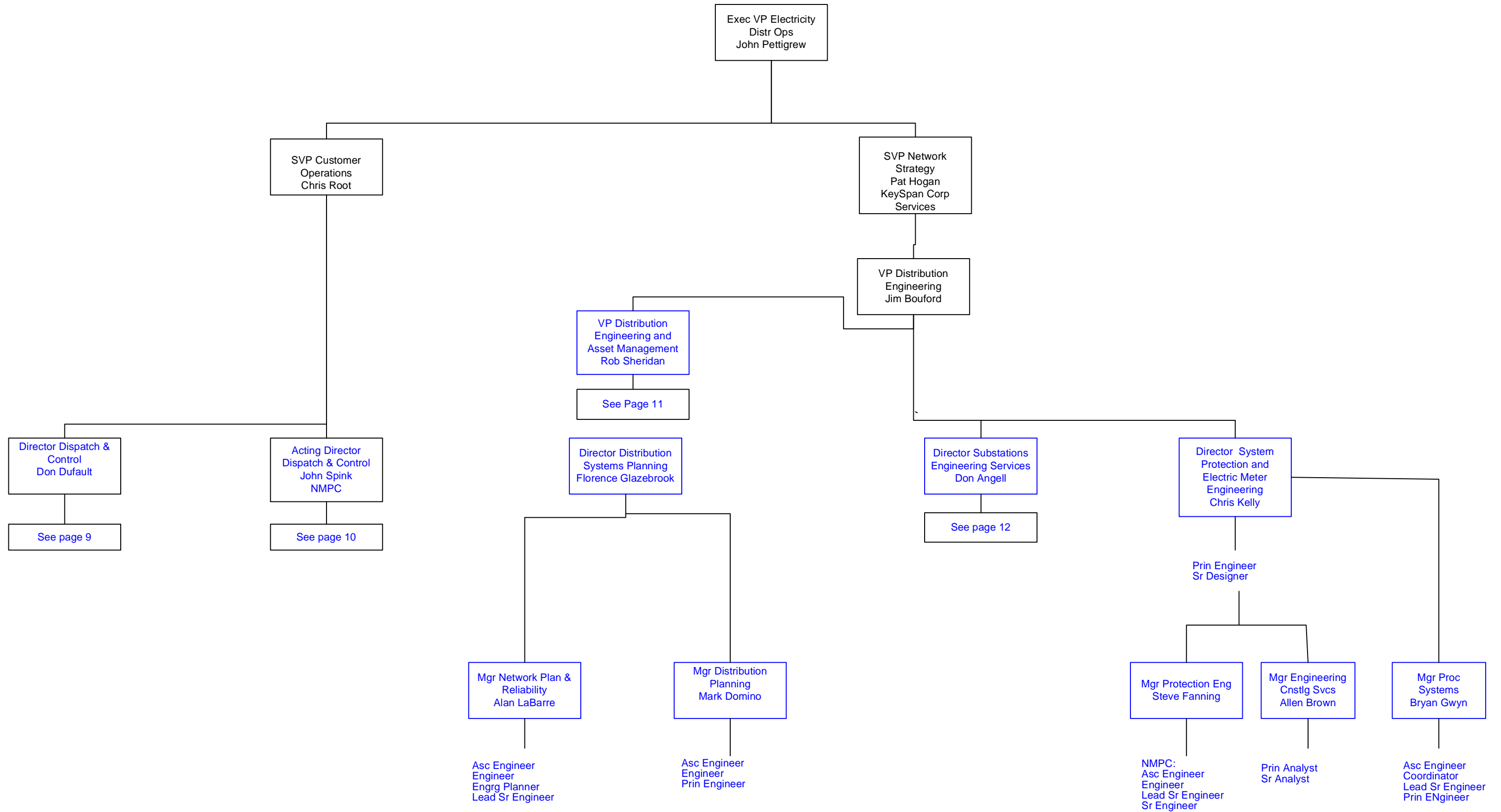

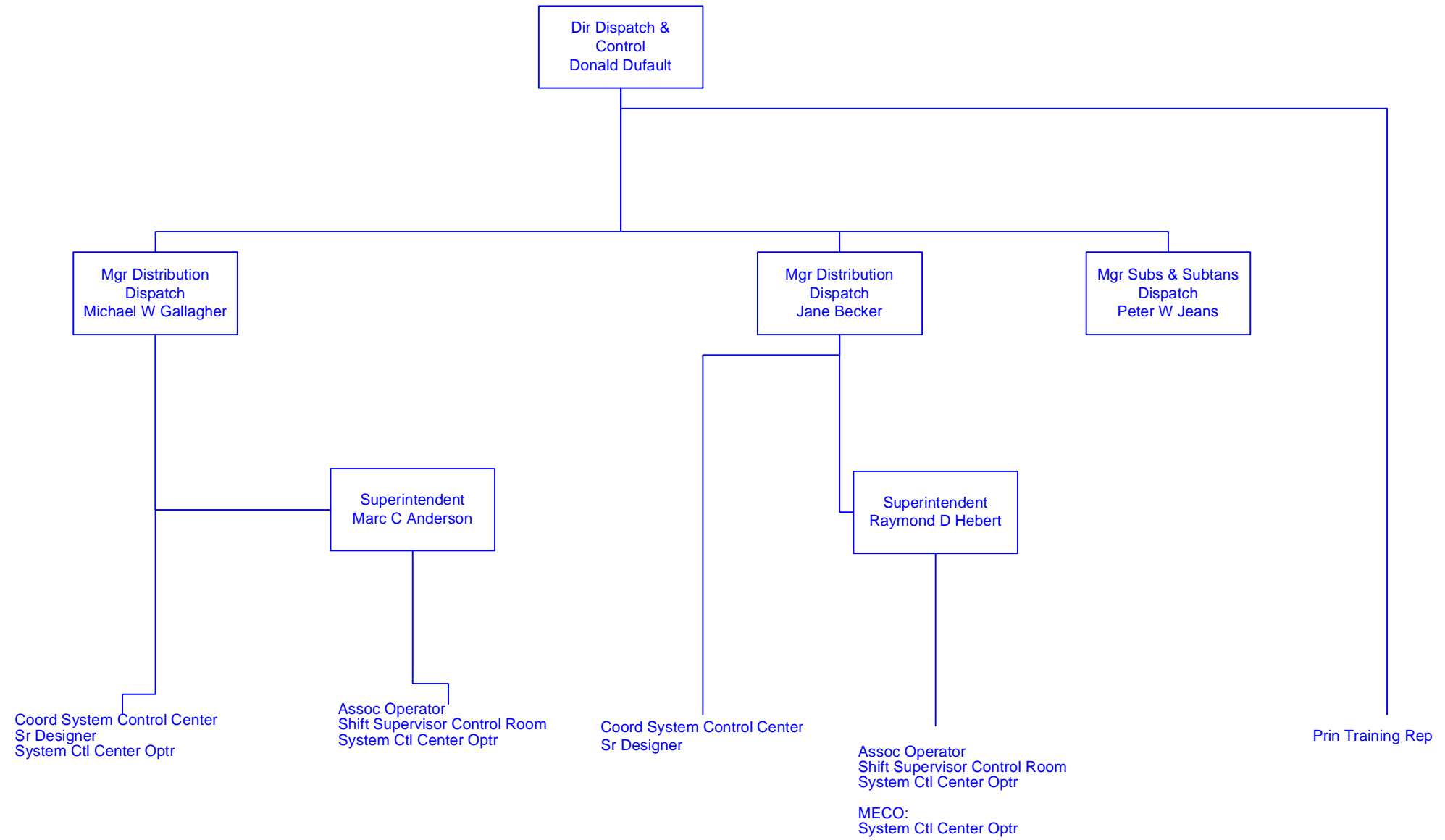

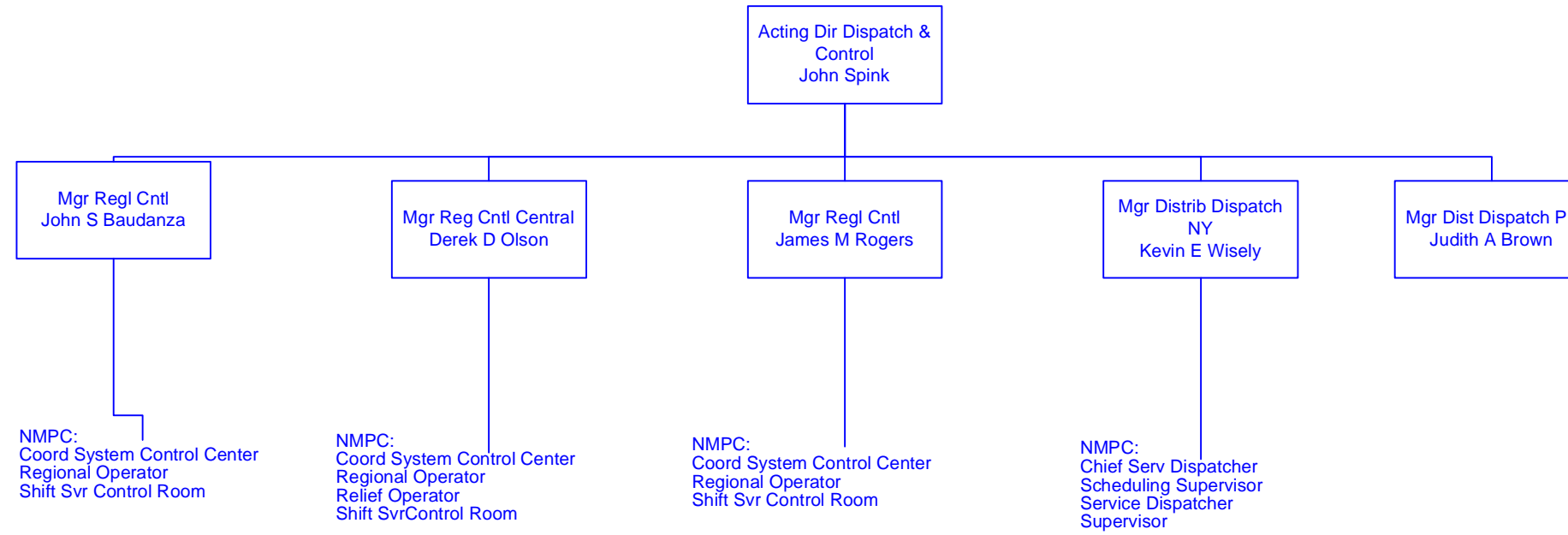

New York Distribution Dispatch and Control

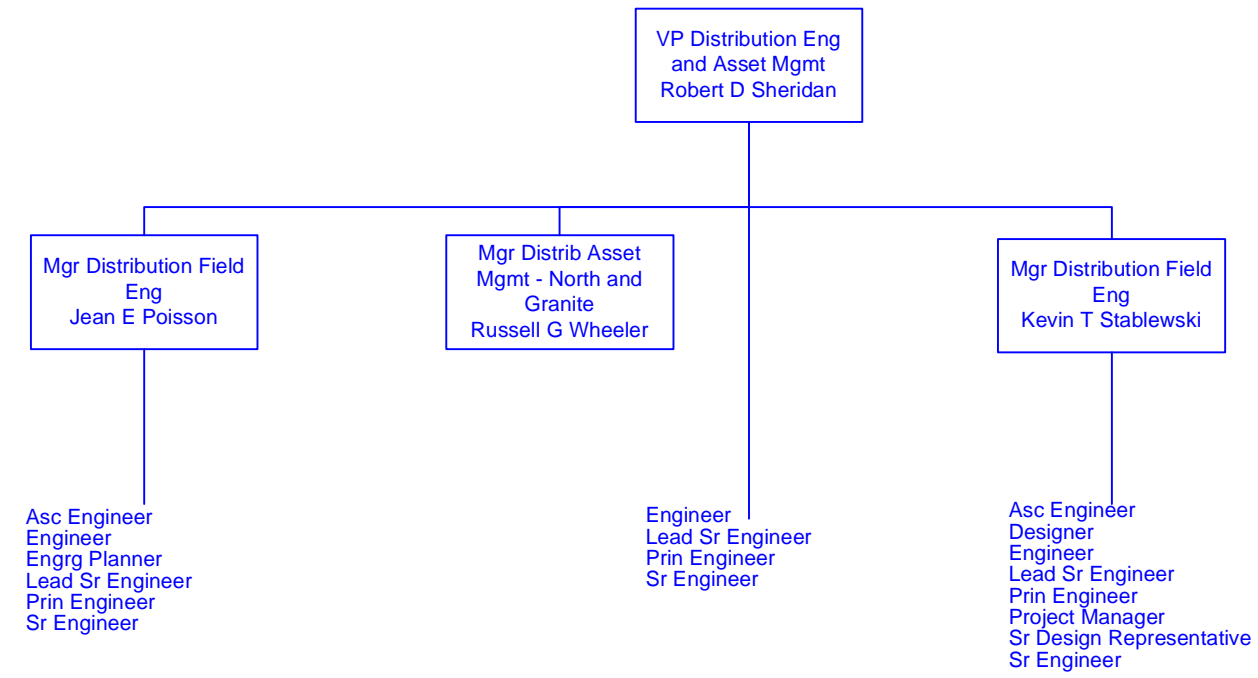

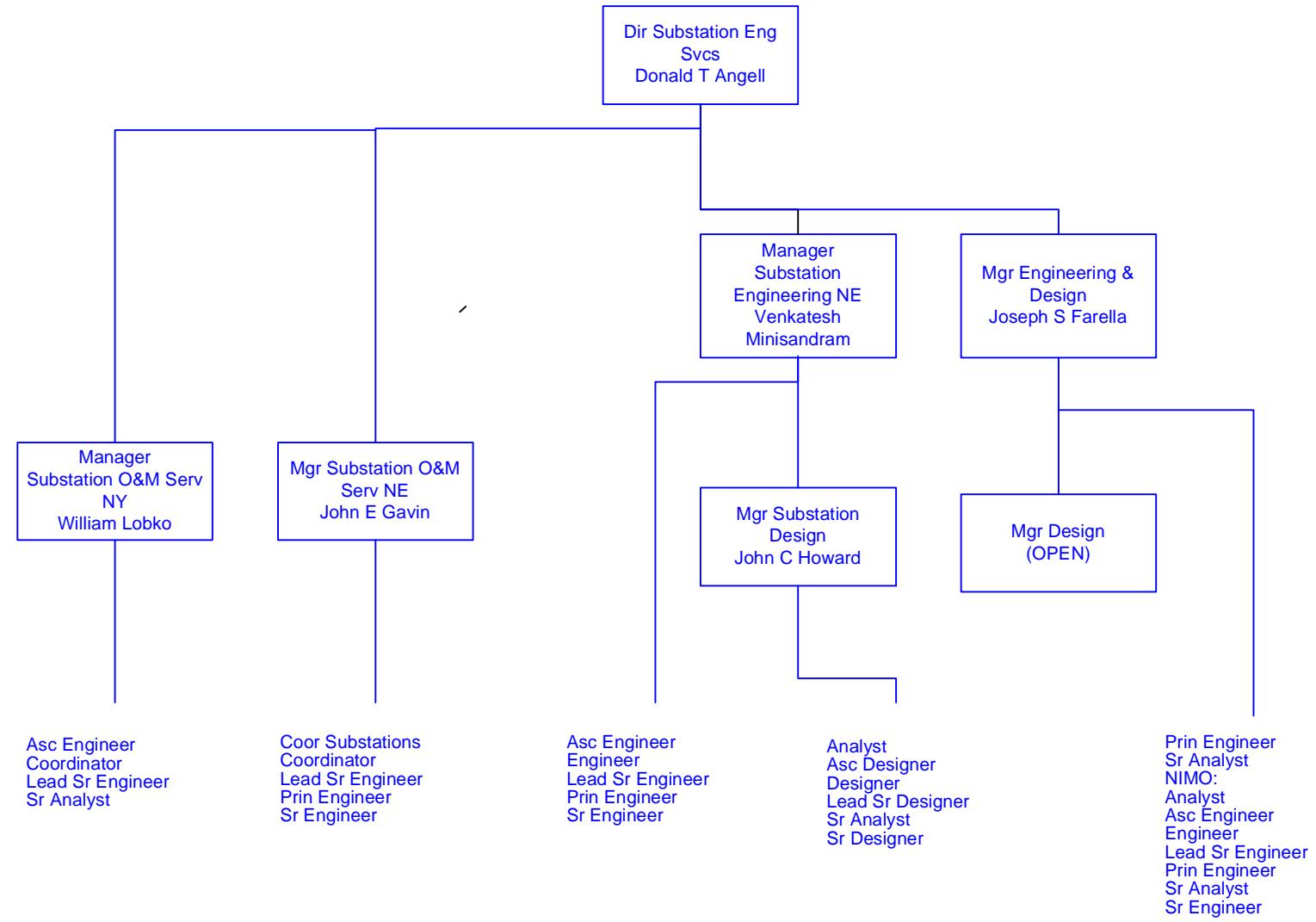

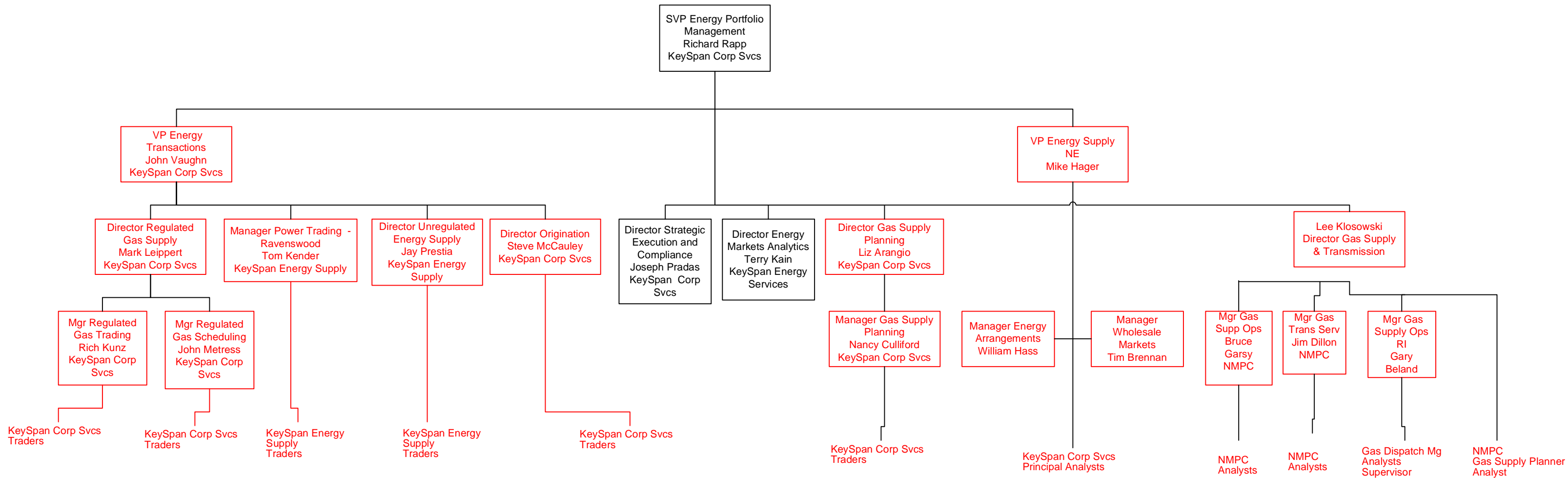

Energy Portfolio

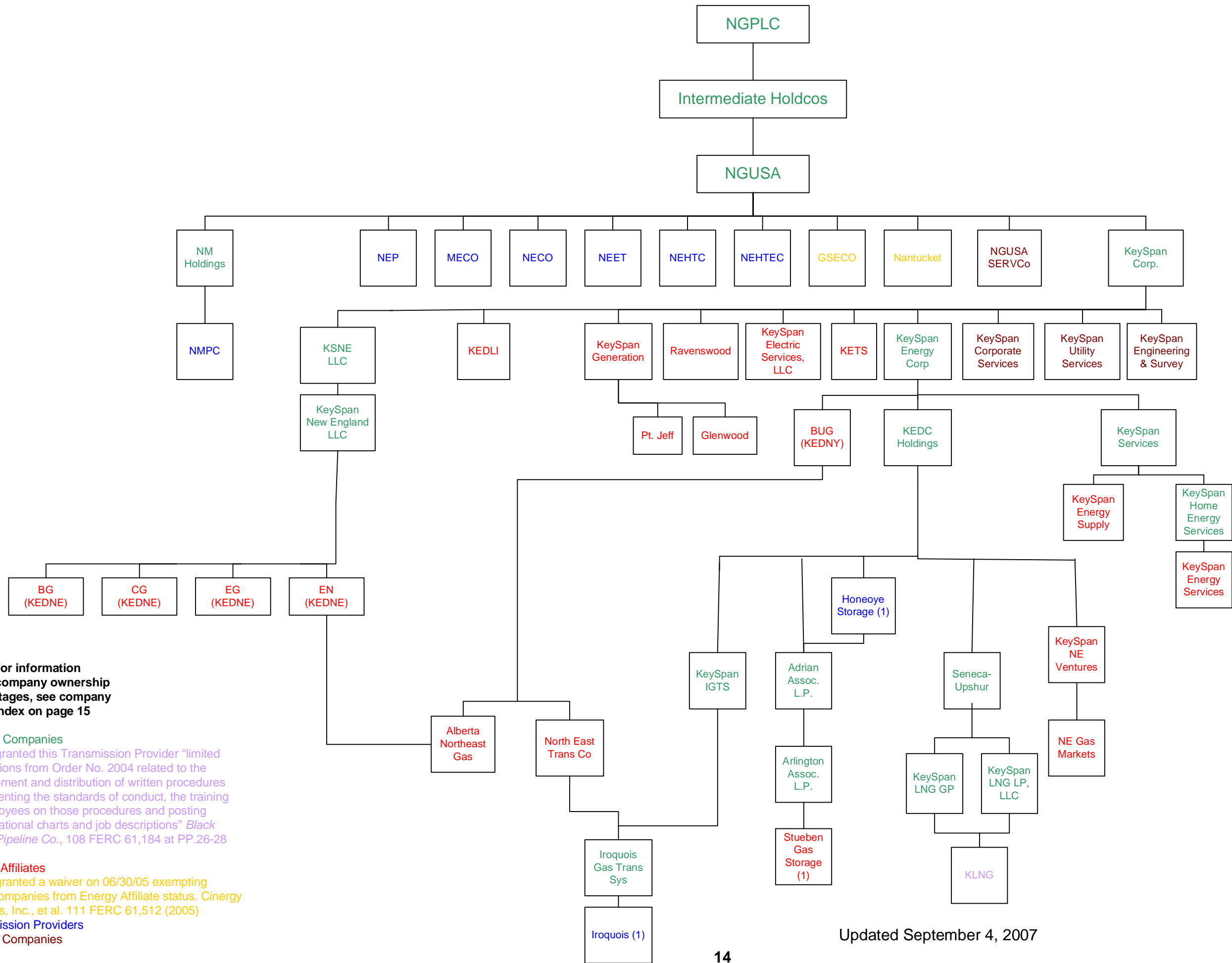
