The customer acknowledges that the monthly/quarterly billing charges listed above are determined pursuant to the Optional Interval Data Service tariff approved by the Rhode Island Public Utilities Commission (RIPUC). The Optional Interval Data Service tariff may change from time to time, but any changes must be approved by the RIPUC. In the event that the fees reflected in the tariff are changed, National Grid will notify the customer of the new fees that will be in effect at the beginning of the next Service Term, but will continue to bill the monthly/quarterly billing charges listed above until the completion of the current Service Term. If National Grid does not receive a written termination request from the customer at least 30 days prior to the end of the current Service Term then, beginning with the next Service Term, National Grid will bill and the customer agrees to pay the new monthly/quarterly billing charges, determined pursuant to the new total annual charge approved by the RIPUC.
