Our facility in Holtsville has been in operation since 1971, and it serves approximately 100,000 customers. The upgrades within the facility do not require any expansion but will increase the safety and reliability of our service to customers by meeting regulatory needs.

The Holtsville facility stores liquefied natural gas (LNG) to be utilized in times of peak demand. This facility helps ensure a sufficient energy supply, maintaining reliable heat for our customers on the coldest days of the year.

From 2025 to 2027, we plan to make the following upgrades to our facility to improve system reliability and align with the latest OSHA safety standards:

- Upgrades to the compressor system.
- Power Distribution Center (PDC) upgrade.
- Upgrade of existing foundation heating system.
- Replacement of tank stairs.

These upgrades mean a safer, more reliable facility for our neighbors in Suffolk County, NY. We're proud to serve Long Island and an upgraded facility means we can continue to do so for decades to come.

Beginning in July 2025, we will begin upgrading our facility in Holtsville, NY. The Holtsville Facility has been serving Long Island safely and reliably since the 1970s. This project aims to upgrade existing equipment to ensure continued service for decades. All construction will occur within the facility, with no expansion required.

Upgrades to our facility:

- Survey of existing facility infrastructure.
- Upgrades to the compressor system.
- Power Distribution Center (PDC) upgrade.
- Upgrade of existing foundation heating system.
- Replacement and inspection of tank stairs.
