

NL-25 Regulator Station Refurbish Project

Elmont, NY | April 2023

Dear Neighbor,

We would like to remind you of continued work in your neighborhood this spring, 2023.

Project details:

This work is the continuation of the NL-25 regulator station refurbish project, which began on Ridge Road, Elmont, in spring 2022.

Starting this spring, our crews start work in the easement on the south side of Dutch Broadway, across from Ridge Road. This work is to decommission the existing regulator station on Dutch Broadway and is the final stage of work for this project.

The NL-25 regulator station refurbish project will improve system integrity and reliability. There will be no interruption of service for our customers.

What to expect during construction:

- **Excavation** within the grass easement on the south side of Dutch Broadway. Open pits will be plated and secured during non-working hours.
- **Restoration** of any disturbed areas.
- **Temporary lane closure** of the righthand lane of Dutch Broadway near Ridge Road during work hours.
- **Direct contact with our Outreach Team.** Please contact us at the number or email on this sheet if you have any questions or concerns regarding this work.
- **Safety is our top priority.**

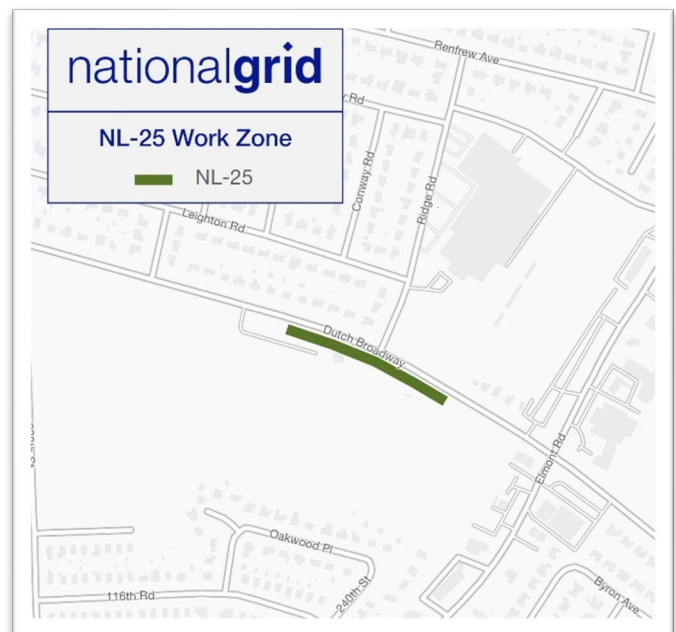

NL-25 Regulator Station Refurbish Project

Frequently Asked Questions



How long will construction be going on outside of my home or business?

The project is scheduled to begin in May 2023 and finish in June 2023.

Where will the project take place?

Construction will be within the grass easement on the south side of Dutch Broadway, near the intersection of Ridge Road.

What type of work is taking place?

This work will involve the decommission and demolition of the existing regulator station. Construction of the new regulator station on Ridge Road has been completed. This is the final stage of this project.

Why is this happening now?

We feel it's important to upgrade our local energy distribution system whenever possible. We want to make sure our Elmont customers continue to receive safe and reliable energy service, especially during the heating season.

Is it safe?

Yes. Safety is our top priority. That includes the safety of our customers, the general public, and our employees and contractors. The professional construction firms we work with also place safety as their top priority.

Will my service be interrupted?

No. This work will be managed so that our service will not be interrupted at all.

Will this project impact traffic?

There will be minor traffic impacts to Dutch Broadway during work hours. The right-hand lane of Dutch Broadway will be closed for approximately 120 feet on either side of Ridge Road.

Will you need to dig on my property and if so, who's going to fix it?

No. Most of the work will take place within established utility corridors.

What kind of noise impacts are expected during construction?

While our contractors will make efforts to keep disturbance to a minimum, there will be noise associated with this project. Most of that noise will occur while excavation is underway as contractors use heavy equipment and sounds from trucks backing up or idling.
