Direct Participation and Shared Savings

- Curtailment service providers (CSPs) help customers to create a curtailment plan; make sure customers are notified for each event by voicemail, email, and/or text message; review customer performance; and, if applicable, help customers to co-enroll in ISO-NE's markets. For their services, CSPs require a portion of a customer's incentive. Your MassSave® sponsor will pay the incentive directly to the CSP. How much of this incentive is passed down to the customer depends on the negotiations between the customer and the CSP.
- Customers may enroll directly into Targeted Dispatch without a CSP. However, the customer will then be responsible for services a CSP would normally provide, and the customer may not be able to co-enroll in ISO-NE's markets. Your MassSave® sponsor will email direct participants event notifications the day before a curtailment event starts.

Eligibility Requirements

- The customer must have an electric account of a sponsor in the State of Massachusetts.
- The customer must be on a commercial electric rate and pay for the energy efficiency fund.
- The customer must enroll before May 31 to participate in that year's program.
- Customers who sign up for the program will remain in the program until they unsubscribe.

About Targeted Dispatch Events

- Events will be called the day before curtailment is needed.
- A maximum of 8 events will be called per summer.
- All events will last for 3 hours and will occur between 2 p.m. and 7 p.m.
- All events will occur on weekdays (not weekends), and not on holidays.
- All events will be called in June, July, August, or September.

Weekend Bonus

Although it is rare, weekend events may be called in the Targeted Dispatch measure. If a weekend
event is called in a summer, customers will be paid an additional \$10/kW-performed incentive for their
average performance over all weekend events for the summer.

About the Incentive

- Incentives will be paid out in November of each year.
- Incentives will be based on the customer's average curtailment amount for all events called that summer.
