The project:

- Old HVAC system removed
- Three heat pumps installed
- The switch to heat pumps reduced greenhouse gas emissions
- Lights also were replaced with LED
- Motion sensors installed in the bathrooms

National Gird incentives of \$33,750 helped to offset the total project cost of \$46,393.



Cascade School Supplies North Adams, MA

Annual Savings = 113,872 kWh annually / approximately \$30,000 a year

Employees at Cascade School Supplies were concerned about the lighting of the facility. After an energy assessment which explored Cascade's gas and electric consumption, lighting fixtures and HVAC systems, a project design was created based on Cascade's desired goals.



"Cascade watches all of its pennies. It is an older company and we do fairly well with our bidding, but as other expenses arise in Massachusetts, such as minimum wage and health insurance, we all know those are pinch points in the economy. Incentives and On-bill Repayment

When you install the efficiency measures recommended from your no-cost, onsite assessment, National Grid will pay up to 70% of the installation and equipment costs.

For eligible customers, the balance can be placed on your monthly electric bill. Or, pay in one lump sum and receive an additional 15% discount.

Eligibility Criteria:

- **Electric:** Average annual usage of 1.5 million kWh (in aggregate by customer) or less
- **Gas:** Average annual usage of 40,000 therms (in aggregate by customer) or less
