

# Electric Vehicle Charging Program Qualified Products List

## Beginning April 1, 2024, National Grid is transitioning hardware qualification to EPRI.

To search the EPRI Vetted Product List (VPL), follow these steps:

1. Go to <https://epri.co/VettedProductList>
2. Navigate to the "Massachusetts" tab to view eligible products

For full product details, search the model number on the Full List tab.

Beginning in January 2025, all L2 and DCFC hardware must be listed on the Massachusetts tab of the EPRI VPL to be eligible for the MA EV Charging Program.

## Qualified EVSE Hardware – Level 2

Beginning April 1, 2024, L2 products are eligible for use in the MA EV Charging Program if they are:

- 1) Listed in the Massachusetts State Appliance Standards Database (SASD): (<https://neep.org/SASD>), and are OCPP-compliant (multi-unit dwellings excluded).

- 2) Listed in the Massachusetts tab of the [EPRI VPL](#).
