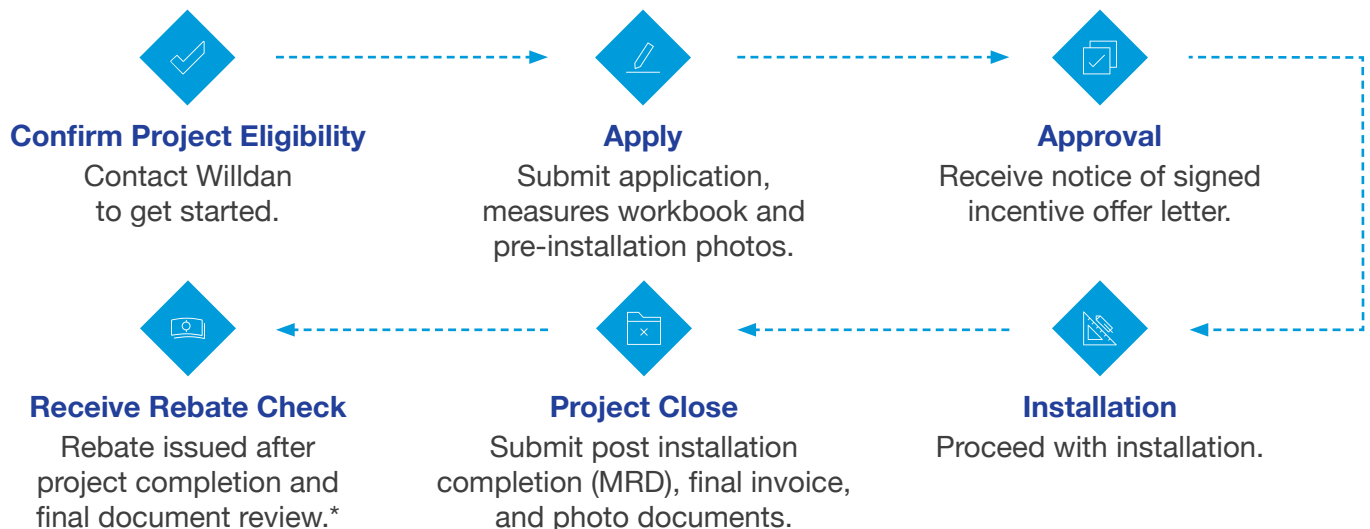

“Bundle Up” Incentive: Customers who install a heat pump and complete qualifying weatherization measures within the same project **may be eligible for the enhanced “Bundle Up” incentive of \$6,500.**

CONTRACTOR STEPS



*Rebate will be issued to the contractor only when the customer has formally assigned rebate rights to the contractor through a signed agreement. Projects may require post inspection.

ELIGIBILITY CRITERIA

Note: Each category may have additional eligibility criteria than what is shown below.

Electric (Upstate New York) Customers must:

- Be an active National Grid electric non-residential customer;
- Have an average annual peak demand under 250 kW;
- Pay into SBC (Systems Benefit Charge) surcharge on the bill.

Gas (Upstate New York) Customers must:

- Be an active National Grid gas non-residential customer;
- Have an annual Therm usage of less than 50,000 Therms;
- Pay into SBC (Systems Benefit Charge) surcharge on the utility bill.

“Bundle Up” Incentive: Customers who install a heat pump and complete qualifying weatherization measures within the same project may be eligible for the enhanced “Bundle Up” incentive of \$6,500. To qualify, the project must meet the equipment requirements of the Small Business Heating Electrification and Weatherization Programs, and the incentive is issued only after a satisfactory post-installation inspection for both the heat pump and the weatherization work. Qualifying weatherization measures for the bundle up incentive are roof, attic, and wall insulation.
