

## Tenant Authorization to Release Energy Information

In an effort to promote energy efficiency and identify energy efficiency improvement opportunities for its customers, National Grid is working with the United States Environmental Protection Agency (“EPA”) to use the EPA’s ENERGY STAR Portfolio Manager tool. The Portfolio Manager is used to benchmark building energy efficiency to help customers assess the energy performance of their building(s) and encourage action to make the building(s) more efficient, and to sustain that efficiency over time. To accomplish this, National Grid needs to disclose the aggregated energy consumption data for your premises. This form is your permission that National Grid may disclose ENERGY STAR Portfolio Manager benchmarking data and ratings.

### Customer understands and agrees to the following:

- (a) The owner, operator, or agent of the owner (collectively, the “Owner”) of the Premises, which is occupied by Customer, may disclose “EPA ENERGY STAR Portfolio Manager benchmarking data and ratings regarding the Premises to
  - (i) Current tenants,
  - (ii) Prospective purchasers and / or lessees of the Premises, and
  - (iii) Current and / or prospective lenders
- (b) National Grid<sup>1</sup> will provide aggregated energy consumption data for National Grid accounts specified by the Owner to the ENERGY STAR Portfolio Manager and such data will include energy consumption data for Customer’s National Grid accounts for the Premises (“Customer Information”). Customer Information does not include Customer identity
- (c) Customer Information will be used by the Owner and ENERGY STAR Portfolio Manager to benchmark energy consumption at the Premises

Customer hereby agrees to release, indemnify and hold harmless National Grid, its affiliates, and their respective employees, directors, officers, agents, successors and assigns from any and all liability, claims, demands, damages or expenses arising out of or resulting from the disclosure of, or use of, the Customer Information, including, without limitation (i) any unauthorized use or disclosure of the Customer Information by the Owner or EPA, (ii) any acts or omissions by the Owner or EPA in connection with the Customer Information, and [(iii) any identification of Customer Information by the EPA, Owner or a third party.]
