Space Heater Safety Tips

- As the cooler weather approaches, individuals often rely on portable space heaters to warm small to medium-sized areas in their homes or offices.
- These portable heaters can cause fires if they are placed to close to combustible materials such as furniture, curtains, bedding, or rugs.
- When using space heaters, please keep these safety tips in mind:
 - Use a space heater with built in safety features like tip-over and overheat protections.
 - Be sure to place space heaters on a level, non-flammable surface at least 3' from combustible materials.
 - Keep children and pets away from space heaters
 - Avoid using extension cords, to help prevent overloading
 - Never leave space heaters unattended, turn off and unplug them when you leave a room
 - Inspect space heaters for damage
 - Avoid using space heaters in wet or damp areas as this increases the risk of electric shock
 - Do not use space heaters to dry clothing
