On August 9, 2022, The Brooklyn Union Gas Company d/b/a National Grid NY (“KEDNY”), KeySpan Gas East Corporation d/b/a National Grid (“KEDLI”), and Niagara Mohawk Power Corporation d/b/a National Grid (“NMPC”) held the Second Stakeholder Meeting for the CLCPA Study that is being developed pursuant to the KEDNY and KEDLI Joint Proposal adopted by the Public Service Commission (“Commission”) on August 12, 2021 in Case 19-G-0309 and Case 19-G-0310 in its *Order Approving Joint Proposal, As Modified and Imposing Additional Requirements* and the NMPC Joint Proposal adopted by the Commission on January 20, 2022, in Case-E-0380 and Case 20-G-0381 in its *Order Adopting Terms of Joint Proposal Establishing Rate Plans and Reporting Requirements*. The Companies held the Second Stakeholder Meeting jointly for both the upstate and downstate CLCPA Study and hereby submit the following:

Comments should refer to "Case 19-G-0309 – The Brooklyn Union Gas Company d/b/a National Grid NY" and "Case 19-G-0310 – KeySpan Gas East Corp. d/b/a National Grid" if submitted for the downstate CLCPA Study, "Case 20-E-0380 – Niagara Mohawk Power Corporation d/b/a National Grid" and "Case 20-G-0381 – Niagara Mohawk Power Corporation d/b/a National Grid" if submitted for the upstate CLCPA Study, or all four Case numbers if comments apply to both studies. Comments are requested by **4 p.m. on August 19, 2022**. All comments submitted to the Secretary and posted on the Department's DMM website will become part of the official case record.
