NOTICE OF FILING AND PUBLIC HEARING

D.P.U. 16-181 December 13, 2016

Petition of Boston Gas Company and Colonial Gas Company, each d/b/a National Grid, for review and approval of their five-year Forecast and Supply Plan for the period November 1, 2016 through October 31, 2021.

On November 1, 2016, Boston Gas Company and Colonial Gas Company, each d/b/a National Grid ("Company"), filed a petition with the Department of Public Utilities ("Department") for approval of the Company's Long-Range Forecast and Supply Plan ("Plan") for the five-year forecast period from November 1, 2016 through October 31, 2021. Pursuant to G.L. c. 164, § 69*I*, the Department must ensure a necessary energy supply for the Commonwealth with a minimum impact on the environment at the lowest possible cost. Accordingly, the Department will review the Company's Plan to ensure that the forecast accurately projects the gas sendout requirements of the utility's market area. The Department docketed this matter as D.P.U. 16-181.

The Attorney General of the Commonwealth of Massachusetts ("Attorney General") filed a notice to intervene in this matter pursuant to G.L. c. 12, § 11E(a). Further, pursuant to G.L. c. 12, § 11E(b), the Attorney General filed a notice of intent to retain experts and consultants ("notice of retention of experts") to assist in her investigation of the Company's filing, and has requested Department approval to spend up to \$150,000 in this regard. Pursuant to G.L. c. 12, § 11E(b), the costs incurred by the Attorney General relative to her retention of experts and consultants may be recovered in the Company's rates. Any person who desires to comment on the Attorney General's notice of retention of experts may submit written comments to the Department not later than the close of business (5:00 p.m.) on **Tuesday, January 31, 2017.**

Copies of the Company's petition and accompanying exhibits and the Attorney General's notice to intervene and notice of retention of experts are available for public viewing during regular business hours at the Department's offices, One South Station, 5th Floor, Boston, Massachusetts 02110 and on the Department's website at http://www.mass.gov/dpu. The Department will conduct a public hearing to receive comments on the Company's petition on **Tuesday**, **January 31**, **2017**, **at 2:00 p.m.** at the Department's offices, One South Station, 5th Floor, Boston, Massachusetts 02110. Any person who desires to comment may do so

at the time and place noted above or submit written comments to the Department not later than the close of business (5:00 p.m.) on **Tuesday, January 31, 2017**. A procedural conference will immediately follow the public hearing.

Any person who desires to participate in the evidentiary phase of this proceeding must file a written petition for leave to intervene with the Department not later than the close of business (5:00 p.m.) on **Tuesday, January 24, 2017**. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 C.M.R. § 1.03. Receipt by the Department, not mailing, constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 C.M.R. § 1.01(4). To be allowed, a petition under 220 C.M.R. § 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10.

The electronic filing must also include the name, title, and telephone number of a person to contact in the event of questions about the filing.
