NOTICE OF FILING, PUBLIC HEARING, AND PROCEDURAL CONFERENCE

D.P.U. 17-110 January 25, 2018

Petition of Massachusetts Electric Company and Nantucket Electric Company d/b/a National Grid requesting approval by the Department of Public Utilities of its Capital Investment Report for calendar year 2016 and CapEx Factors for effect March 1, 2018.

On June 30, 2017, Massachusetts Electric Company and Nantucket Electric Company d/b/a National Grid ("National Grid" or "Company") filed with the Department of Public Utilities ("Department") a report of its capital investments for the 2016 calendar year. The Company states that the filing is made in accordance with the directives of the Department in Massachusetts Electric Company/Nantucket Electric Company, D.P.U. 15-155 (2016), and the Company's Capital Investment Recovery Mechanism ("CIRM"), M.D.P.U. No. 1303. On January 12, 2018, National Grid submitted its cumulative revenue requirement, proposed Capital Expenditure Factors ("CapEx Factors"), and proposed Capital Expenditure Adjustment Factors ("CapEx Adjustment Factors") for effect March 1, 2018. The Attorney General of the Commonwealth of Massachusetts ("Attorney General") has filed a notice to intervene in this matter pursuant to G.L. c. 12, § 11E(a). The Department has docketed this matter as D.P.U. 17-110.

Pursuant to M.D.P.U. No 1303, National Grid is required to make two annual filings. First, on July 1st of each year, National Grid must submit a report of its capital investments for the prior calendar year. The report is intended to provide documentation supporting the Company's capital expenditures in the previous year and sufficient information to allow the Department to review the Company's actual capital expenditures for the purposes of determining the Company's cumulative revenue requirement and subsequent CapEx Factors. Second, National Grid must file its proposed CapEx Factors by January 15th of the following year, for effect March 1st of the same year.

National Grid reports total capital expenditures of \$263,894,612 for the 2016 calendar year, which includes gross plant additions and the cost of removal. The Company proposes to include a total of \$53,463,712 in rates, which includes a cumulative revenue requirement of \$53,146,863 and a prior recovery period reconciliation balance of \$316,849. If approved, the total of \$53,463,712 will be recovered from National Grid's customers through the CapEx Factors and CapEx Adjustment Factors, for effect March 1, 2018.

The Company proposes the following CapEx Factors and CapEx Adjustment Factors, effective March 1, 2018, through February 28, 2019:

If the Company's CapEx Factors are approved, a residential customer using 600 kilowatt hours ("kwh") per month will see a bill increase of \$1.18 or 0.8 percent. General Service customers will see monthly bill increases ranging from 0.3 percent to 0.7 percent.

The Department will conduct a public hearing to receive comments on the Company's petition on **February 15, 2018, at 2:00 p.m.**, at the Department's offices, One South Station, 5th Floor, Boston, Massachusetts. A procedural conference will take place immediately following the public hearing. Any person who desires to comment may do so at the time and place noted above or submit written comments no later than the close of business (5:00 p.m.) on **February 14, 2018**.

Any person who desires to participate in the evidentiary phase of this proceeding must file a written petition for leave to intervene or to participate in the proceeding no later than the close of business (5:00 p.m.) on **February 14, 2018**. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 C.M.R. § 1.01(4). To be allowed, a petition under 220 C.M.R. § 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10.
