## **NOTICE OF FILING AND REQUEST FOR COMMENTS**

D.P.U. 22-71 July 19, 2023

Petition of Massachusetts Electric Company and Nantucket Electric Company, each d/b/a National Grid for approval by the Department of Public Utilities of two long-term contracts for procurement of offshore wind energy generation, pursuant to St. 2008, c. 169, § 83, as amended by St. 2016, c. 188, § 12; St. 2021, c. 8 § 91 et seq.; and St. 2021, c. 24, §§ 69, 72; and 220 CMR 23.00.

On May 25, 2022, Massachusetts Electric Company and Nantucket Electric Company, each d/b/a National Grid (together "National Grid" or "Companies") filed a petition with the Department of Public Utilities ("Department") seeking approval of two power purchase agreements ("PPAs") to purchase offshore wind energy generation with Mayflower Wind LLC and Commonwealth Wind LLC ("Commonwealth Wind"). The Companies filed the long-term contracts pursuant to An Act Relative to Green Communities, St. 2008, c. 169, § 83, as amended by St. 2016, c. 188, § 12; St. 2021, c. 8 § 91 et seq.; and St. 2021, c. 24, §§ 69, 72 and the Department's regulations at 220 CMR 23.00. The Department docketed this matter as D.P.U. 22-71.

The Department issued a final order approving the PPAs on December 30, 2022. <u>NSTAR</u> <u>Electric Company, et al.</u>, D.P.U. 22-70/D.P.U. 22-71/D.P.U. 20-72, at 46 (2022). On January 19, 2023, Commonwealth Wind appealed the Department's final order. That appeal is currently pending.

On July 13, 2023, the Companies filed an amendment to their PPA with Commonwealth Wind seeking the Department's approval to terminate the PPA ("Amendment"). If the Department approves the Amendment, Commonwealth Wind shall pay to National Grid a termination payment of \$21,619,200 that will be credited to National Grid's customers. In addition, Commonwealth Wind shall withdraw or have dismissed its appeal of the Department's final order approving Commonwealth Wind's PPAs.

Any person interested in commenting on the proposed Amendment may submit written comments no later than the close of business (5:00 p.m.) on August 2, 2023.
