### NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 22-29

March 30, 2022

Petition of Massachusetts Electric Company and Nantucket Electric Company, each d/b/a National Grid, for review and approval of their basic service costs adder rate adjustment for effect May 1, 2022.

On March 15, 2022, Massachusetts Electric Company and Nantucket Electric Company, each doing business as National Grid (“Companies”), filed with the Department of Public Utilities (“Department”), their annual basic service costs adder (“BSCA”) rate adjustment and reconciliation filing. The Department docketed this matter as D.P.U. 22-29.

The Companies propose to recover or return through their BSCA the reconciliation of their electric supply-related costs and revenues from January 2021 through December 2021 and their supply-related forecasted costs from January 2022 through December 2022, which include: (1) cash working capital; (2) bad debt; (3) administration of basic service; (4) conducting the competitive bidding processes; and (5) regulatory compliance.

The Companies propose the following BSCAs to take effect on May 1, 2022: (1) \$0.00226 per kilowatt-hour (“kWh”) for residential customers; (2) \$0.00104 per kWh for commercial customers (rate classes G-1 and streetlighting); and (3) \$0.00061 per kWh for industrial customers (rate classes G-2 and G-3).

If the Companies’ BSCAs are approved as proposed, the monthly bill for an average basic service residential customer (i.e., a customer using 600 kWh of electricity per month) will increase by approximately \$1.57, or 0.9 percent. The bill impacts for all customers will be an increase of no more than one percent per month. For specific bill impacts depending on class and usage, please contact the Companies as shown below.

Any person interested in commenting on this matter may submit written comments no later than the close of business (5:00 p.m.) on **Wednesday, April 13, 2022**. To the extent a person or entity wishes to submit comments in accordance with this Notice, electronic submission, as detailed below, is sufficient.

Ordinarily, all parties would follow Sections B.1 and B.4 of the Department’s Standard Ground Rules (D.P.U. 15-184-A, App. 1 (March 4, 2020)). However, at this time, all filings will be submitted only in electronic format consistent with the Commission’s June 15, 2021 Memorandum related to continued modified filing requirements. Until further notice, parties

must retain the original paper version of the filing and the Department will later determine when the paper version must be filed with the Department Secretary.

All documents must be submitted to the Department in **pdf format** by e-mail attachment to [dpu.efiling@mass.gov](mailto:dpu.efiling@mass.gov) and [henry.d.kahn@mass.gov](mailto:henry.d.kahn@mass.gov). The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 22-29); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. Importantly, all large files submitted must be broken down into electronic files that do not exceed 20 MB.
