NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 16-158 October 12, 2016

Petition of Massachusetts Electric Company and Nantucket Electric Company, each d/b/a National Grid, for Approval of its Renewable Energy Recovery Factor, for effect November 1, 2016 through February 28, 2017.

On September 15, 2016, Massachusetts Electric Company and Nantucket Electric Company, each d/b/a National Grid (together "National Grid" or "Company"), filed with the Department of Public Utilities ("Department") its proposed renewable energy recovery factor ("RERF"), for effect November 1, 2016 through April 30, 2017. This filing was made pursuant to Fitchburg Gas and Electric Light Company d/b/a Unitil, et al., D.P.U. 13-146/D.P.U. 13-147/D.P.U. 13-148/D.P.U. 13-149 (2014) and the Company's Renewable Energy Recovery Provision ("RERP") tariff, M.D.P.U. No. 1235. Under the RERP tariff, the Company's distribution rates are subject to adjustment to reflect the recovery of payments under the Company's long term renewable energy contracts executed pursuant to § 83A of the Green Communities Act, St. 2008, c. 169, as amended by St. 2012, c. 209, § 36, along with contract remuneration associated with payments made under such contracts. The Department docketed the Company's petition as D.P.U. 16-158.

On October 7, 2016, the Company filed a revised RERF, for effect November 1, 2016 through February 28, 2017, to transition to an annual RERF filing effective March 1, 2017, consistent with the Department's directives in Massachusetts Electric Company and Nantucket Electric Company, D.P.U. 16-34-A (September 30, 2016). In its revised filing, the Company proposes a RERF of \$(0.00012) per kilowatt-hour ("kWh") for all rate classes for effect November 1, 2016 through February 28, 2017. If the Department approves the proposed RERF, the average National Grid basic service residential customer (R-1) using 600 kWh of electricity per month will experience a monthly bill decrease of \$0.14, or a bill decrease of 0.1 percent. For specific bill impacts, please contact the Company as indicated below.

Any person interested in commenting on this matter may submit written comments no later than the close of business (5:00 p.m.) on **Friday, October 28, 2016**. The electronic filing should also include the name, title, and telephone number of a person to contact in the event of questions about the filing.
