NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 16-58 June 29, 2016

Petition of Boston Gas Company and Colonial Gas Company d/b/a National Grid for approval by the Department of Public Utilities of its proposed Calendar Year 2015 Targeted Infrastructure Recovery Factors for effect November 1, 2016.

On April 29, 2016, Boston Gas Company and Colonial Gas Company d/b/a National Grid ("National Grid" or "Company") filed a petition with the Department of Public Utilities ("Department") for approval of the revenues to be collected through its annual Targeted Infrastructure Recovery Factors ("TIRFs") for calendar year 2015, for rates in effect November 1, 2016, made in accordance with the directives of the Department in Boston Gas Company and Colonial Gas Company d/b/a National Grid, D.P.U. 10-55 (2010) and the Company's approved Local Distribution Adjustment Clause ("LDAC") tariff, M.D.P.U. No. 3. The Department has docketed this matter as D.P.U. 16-58.

National Grid's TIRF mechanism allows for the annual recovery of the accumulated revenue requirement associated with the costs of replacing its non-cathodically protected steel and small diameter (less than or equal to eight (8) inches in diameter) cast/wrought iron gas distribution mains, services and other eligible facilities starting in calendar year 2010, as a component of the Company's Local Distribution Adjustment Factor ("LDAF"). The Department will analyze the charges and bill impacts associated with the TIRFs in the Company's LDAF filing for rates effective November 1, 2016.

For Boston Gas Company, National Grid states that it had \$8,052,382 in TIRF-recoverable net capital additions that represent carry-over costs for plant and equipment that the Company placed into service prior to December 31, 2014 but did not book until calendar year 2015. This results in an increase to the TIRF revenue requirement of \$3,009,549. The Company proposes a total revenue requirement based on the cumulative investment in TIRF-eligible infrastructure of \$61,873,675.

For Colonial Gas Company, National Grid states that it made \$2,833,103 in TIRF-recoverable net capital additions that represent carry-over costs for plant and equipment that the Company placed into service prior to December 31, 2014 but did not book until calendar year 2015. This results in an increase to the TIRF revenue requirement of

\$1,083,550. The Company proposes a total revenue requirement based on the cumulative investment in TIRF-eligible infrastructure of \$10,503,263.
