NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 17-POR-01

March 24, 2017

Petition of Massachusetts Electric Company and Nantucket Electric Company d/b/a National Grid pursuant to the Company's Tariffs M.D.P.U. Nos. 1201 , § 8B and 1202, § 8B for review and approval by the Department of Public Utilities of the Company's Standard Complete Billing Percentages for effect May 1, 2017, under the Company's Purchase of Receivables Program.

On March 15, 2017, Massachusetts Electric Company and Nantucket Electric Company d/b/a National Grid ("Company") filed with the Department of Public Utilities ("Department") its calculation of purchase of receivables ("POR") discount rates by customer class for effect May 1, 2017. The Company made this filing pursuant to the Company's POR Program set forth in Terms and Conditions for Competitive Suppliers tariffs, M.D.P.U. Nos. 1201 , § 8B and 1202, § 8 B. The Department has docketed this filing as D.P.U. 17-POR-01.

The Company's POR Program provides for the Company to purchase, at a discounted rate, the billing accounts receivable of competitive suppliers operating in the Company's service territory that take standard complete billing service from the Company. The discounted rate, called the standard complete bill percentage ("SCBP"), is set annually for effect May 1 for a 12-month period. The SCBP is comprised of the following: (1) the uncollectible percentage, which is calculated for each customer class based on actual uncollectible expense data for all distribution customers in that class; (2) administrative costs incurred by the Company in implementing the POR Program; and (3) the reconciliation of projected and actual uncollectible expenses experienced during the previous year. M.D.P.U. No. 1201, § 8B.2.b; M.D.P.U. No. 1202, § 8B.2.b.

In its filing, the Company proposes the following SCBPs for effect May 1, 2017:

Commercial	1.12 %
Industrial	0.03 %

Also, the Company states that the average historical payment periods that will be in place effective May 1, 2017 are as follows:

In addition, the Company filed its prior period reconciliations for 2015 and 2014 where it calculated the (1) net under recovery of competitive supplier balances incurred through December 2015 and (2) final reconciliation of the over recovery balance refunded to competitive suppliers incurred through December 2014.
