NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 18-27 March 29, 2018

Request of Boston Gas Company and Colonial Gas Company each d/b/a National Grid for approval of the ratemaking treatment associated with the terms of its Settlement with the Attorney General regarding the improper assessment of certain reconnection fees for non-payment of service.

On March 9, 2018, Boston Gas Company and Colonial Gas Company, each d/b/a National Grid ("National Grid"), filed with the Department of Public Utilities ("Department"), a request for approval of the ratemaking treatment associated with the terms of a settlement agreement that National Grid entered into with the Attorney General of the Commonwealth ("Attorney General") on March 6, 2018 ("Settlement"). The Settlement concerns certain residential natural gas customers who were disconnected for non-payment and incorrectly assessed reconnection fees between November 10, 2010 and November 4, 2016.

Among other things, the Settlement establishes a fund to repay all affected customers, with interest ("Restitution Fund"), and provides that any remaining balance in the Restitution Fund be credited to all of National Grid's customers through its Residential Assistance Adjustment Factor ("RAAF"). The Department has jurisdiction to review the subject matter of the Settlement, including any proposed changes to the RAAF, pursuant to the Department's general supervisory authority over natural gas distribution companies under G.L. c. 164, § 76 as well as the Department's authority to set rates under G.L. c. 164, § 93, 94. The Department has docketed this filing as D.P.U. 18-27.
