NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 20-SQ-12

April 10, 2020

Investigation by the Department of Public Utilities into Nantucket Electric Company d/b/a National Grid's 2019 Service Quality Report filed pursuant to Service Quality Standards for Electric Distribution Companies and Local Gas Distribution Companies, D.P.U. 12-120-D (2015).

On February 28, 2020, Nantucket Electric Company d/b/a National Grid ("Company") filed with the Department of Public Utilities ("Department") the Company's 2019 service quality report ("2019 SQ Report") for the period January 1, 2019 through December 31, 2019. The Company's 2019 SQ Report compares its performance during 2019 with the Department's service quality guidelines set forth in Service Quality Standards for Electric Distribution Companies and Local Gas Distribution Companies, D.P.U. 12-120-D (2015) ("SQ Guidelines"), and the Company's service quality plan that the Department approved in Massachusetts Electric Company and Nantucket Electric Company d/b/a National Grid, D.P.U. 16-88 (2017)). Per the SQ Guidelines, electric distribution companies may be subject to penalties for failure to meet the Department's SQ performance standards for: System Average Interruptions Duration Index ("SAIDI"); System Average Interruptions Frequency Index ("SAIFI"); Circuit Average Interruptions Duration Index ("CKAIDI"); Circuit Average Interruptions Frequency Index ("CKAIFI"); Customer Complaints; and Customer Credit Cases. The Department has docketed this matter as D.P.U. 20-SQ-12.

The Department will accept written comments on the Company's 2019 SQ Report. Any person interested in commenting on this matter may submit written comments no later than the close of business (5:00 p.m.) on **May 27, 2020**. At this time, all filings will be submitted only in electronic format in recognition of the difficulty that parties and the Department may have filing and receiving original copies. On March 10, 2020, Governor Baker issued a state of emergency related to COVID-19 for the entire Commonwealth. Ordinarily, all parties would follow Sections B.1 and B.4 of the Department's Standard Ground Rules (D.P.U. 15-184-A, App. 1 (March 4, 2020)); however, until further notice, parties must retain the original paper version and the Department will later determine when the paper version must be filed with the Department Secretary. Importantly, all large files submitted must be broken down into electronic files that do not exceed 20 MB.

All documents must be submitted to the Department in pdf format by e-mail attachment to peter.ray@mass.gov and Lauren.Morris@mass.gov. The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 20-SQ-12); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. All documents submitted in electronic format will be posted on the Department's website as soon as practicable at <http://www.mass.gov/dpu>. To the extent a person or entity wishes to submit comments in accordance with this Notice, electronic submission, as detailed above, is sufficient. A paper copy of the filing will not be available for public viewing at the Company's offices or the Department due to the state of emergency.
