NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 25-OGAF-GRID

April 4, 2025

Petition of Boston Gas Company d/b/a National Grid pursuant to G.L. c. 164 and 220 CMR 6.00 for approval of its revised 2024/2025 local distribution adjustment factor and peak gas adjustment factor filings, effective May 1, 2025.

On March 17, 2025, Boston Gas Company d/b/a National Grid ("Company" or "National Grid") filed with the Department of Public Utilities ("Department") its off-peak gas adjustment factor ("GAF"), pursuant to G.L. c. 164 and 220 CMR 6.00. The filing includes the Company's off-peak GAFs for effect May 1, 2025, through October 31, 2025, as well as the reconciliation of its 2024 off-peak period gas costs. On April 2, 2025, the Company filed a revision to its local distribution adjustment factor ("LDAF"), pursuant to G.L. c. 164 and 220 CMR 6.11. The filing includes a bill mitigation recovery factor to recover the costs deferred during the peak period, and updated energy efficiency surcharges to revise the residential energy efficiency budget as directed in the Department's Order in 2025-2027 Three-Year Energy Efficiency Plans, D.P.U. 24-140 through D.P.U. 24-149, at 204 (February 28, 2025). The Department has docketed both of these petitions as D.P.U. 25-OGAF-GRID.

The table below summarizes the proposed LDAF rates in dollars per therm:

If the Department approves the Company's LDAFs as proposed, a typical Boston Gas residential heating customer will see an average monthly bill increase of \$7.15 or 15 percent, and a typical former Colonial Gas residential heating customer will see an average monthly bill increase of \$7.15 or 16.3 percent, compared to the LDAF currently in effect. If the Department approves the Company's GAFs as proposed, a typical Boston Gas residential heating customer will see an average monthly bill increase of \$3.27 or 7.0 percent, compared to the 2024 off peak period. A typical Colonial Gas residential heating (R-3) customer will see an average monthly bill increase of \$3.27 or 7.6 percent, compared to the 2024 off peak period. For specific bill impacts, please contact the Company as shown below.

National Grid may, at any time during the off-peak period, submit an amended GAF filing. The amended GAF filing must be submitted seven business days before the first billing cycle of the month in which it is proposed to take effect.

The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 25-OGAF-GRID); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. All documents submitted in electronic format will be posted on the Department's online File_Room (enter "25-OGAF-GRID" on the line for Docket No.).
