# **NOTICE OF FILING AND REQUEST FOR COMMENTS**

D.P.U. 25-78 August 20, 2025

2024 Annual Report of Boston Gas Company d/b/a National Grid regarding the Geothermal Energy Demonstration Program

On July 1, 2025, Boston Gas Company d/b/a National Grid ("Company" or "Boston Gas") filed with the Department of Public Utilities ("Department") its 2024 Annual Report on the Company's Geothermal Energy Demonstration Program ("Geothermal Program"), pursuant to Boston Gas Company, D.P.U. 21-24 (2021), Boston Gas Company, D.P.U. 22-62, (2022), and Section 12.7 of the Company's Local Distribution Adjustment Factor tariff, M.D.P.U. No. 60.9 ("LDAC Tariff"). On August 20, 2025, the Attorney General of the Commonwealth of Massachusetts ("Attorney General") filed a notice to intervene in this matter pursuant to G.L. c. 12, § 11E. The Department has docketed this petition as D.P.U. 25-78.

In December 2021, the Department approved the Company's Geothermal Program, in which the Company will oversee the installation, operation, and maintenance of up to four geothermal shared-loop systems that consist of ground-source heat pumps connected to a network of underground pipes. The Geothermal Program is designed to study the ability of these systems to: (1) reduce emissions resulting from customer energy use; (2) promote non-pipeline alternatives; (3) encourage the development of sustainable heating options; and (4) develop new technologies to advance low-carbon heating solutions. The Department approved a budget for the Geothermal Program of \$15.6 million.

Pursuant to the Company's LDAC Tariff, M.D.P.U. No. 60.9, Boston Gas must submit annual filings related to its Geothermal Program for the Department's review on or before July 1 of each year. The Geothermal Program annual filings include the capital project documentation for projects recorded as in-service during the prior program year and other documentation supporting eligible operations and maintenance ("O&M") expenses incurred. The annual report shall also include progress and results of the Geothermal Program, including progress against goals, construction progress, outreach and education efforts, data collected and analyzed, interim lessons learned, and financial performance against the budget.

The Department previously approved the Company's requests in its first and second annual filings to delay review of the calendar year ("CY") 2022 and CY 2023 costs. Accordingly, this proceeding will address Boston Gas's proposed costs for CY 2022, 2023, and 2024. The Company seeks to recover \$440,975 in incremental O&M expenses associated with

its Geothermal Program through its proposed 2024 Geothermal District Energy Program Factors for effect November 1, 2025.

In addition to cost recovery, the Company also proposes several changes to the Geothermal Energy Provision of its LDAC tariff, M.D.P.U. No. 60.9, Section 12.0. First, the Company proposes to add prudently incurred costs associated with the termination of projects within the Geothermal Program to the definition of O&M expenses eligible for recovery. The Company also proposes to include costs incurred to provide reasonable and prudent electrification measures for customers who signed a customer agreement to participate in the Lowell project prior to its termination. Second, the Company seeks to revise the participant fee to \$10 per month, per apartment. Third, the Company proposes striking the tariff language prohibiting large and extra-large commercial and industrial customers from participating in the GEP.

If the Department approves the Company's petition as filed, a typical residential heating customer using 106 therms will see an average peak period monthly bill increase of \$0.05. A typical low-income residential heating customer using 106 therms will see an average peak period monthly bill increase of \$0.03. For specific bill impacts for commercial and industrial customers, please contact the Company as shown below.

Any person interested in commenting on this matter may submit written comments to the Department not later than the close of business (5:00 p.m.) on **Tuesday, September 30, 2025**. Please note that in the interest of transparency any comments will be posted to our website as received and without redacting personal information, such as addresses, telephone numbers, or email addresses. As such, consider the extent of information you wish to share when submitting comments. The Department strongly encourages public comments to be submitted by email. If, however, a member of the public is unable to send written comments by email, a paper copy may be sent to Mark D. Marini, Secretary, Department of Public Utilities, One South Station, Boston, Massachusetts, 02110.

Any person who otherwise desires to participate in the evidentiary phase of this proceeding shall file a petition for leave to intervene no later than the close of business (5:00 p.m.) on **Tuesday, September 9, 2025**. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 CMR 1.03. Receipt by the Department, not mailing, constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.01(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10. All responses to petitions to intervene must be filed by the close of business (5:00 p.m.) on the second business day after the petition to intervene was filed.

All documents should be submitted to the Department in .pdf format by e-mail attachment to dpu.efiling@mass.gov and lauren.macarthur@mass.gov. The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 25-78); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. The electronic file name should identify the document but should not exceed 50 characters in length. Importantly, all large files submitted must be broken down into electronic files that do not exceed 20 MB. All documents submitted in electronic format will be posted on the
