NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 25-POR-01

March 31, 2025

Petition of Massachusetts Electric Company and Nantucket Electric Company each d/b/a National Grid pursuant to the Companies' Tariffs M.D.P.U. Nos. 1420 and 1421, § 8B, for review and approval by the Department of Public Utilities of the Companies' Standard Complete Billing Percentages for effect May 1, 2025, under the Companies' Purchase of Receivables Program.

On March 14, 2025, Massachusetts Electric Company and Nantucket Electric Company each d/b/a National Grid ("Companies") filed with the Department of Public Utilities ("Department") their calculation of purchase of receivables ("POR") discount rates by customer class for effect May 1, 2025. The Companies made this filing pursuant to the Companies' POR Program set forth in Terms and Conditions for Competitive Suppliers (M.D.P.U. No. 1420, § 8B) and Terms and Conditions for Municipal Aggregators (M.D.P.U. No. 1421, § 8B). The Department docketed this filing as D.P.U. 25-POR-01.

The Companies' POR Program provides for the Companies to purchase, at a discounted rate, the billing accounts receivable of competitive suppliers operating in the Companies' service territories that take standard complete billing service from the Companies. The discounted rate, called the standard complete bill percentage ("SCBP"), is set annually for effect May 1 for a 12-month period. The SCBP is comprised of the following: (1) the uncollectible percentage, which is calculated for each customer class based on actual uncollectible expense data for all distribution customers in that class; (2) administrative costs incurred by the Companies in implementing the POR Program; and (3) the reconciliation of projected and actual uncollectible expenses experienced during the previous year. M.D.P.U. No. 1421, § 8B.2.b; M.D.P.U. No. 1420, § 8B.2.b.

In its filing, the Companies propose the following SCBPs for effect May 1, 2025:

Customer Class	SCBP
Residential	2.68%
Commercial	3.39%
Industrial	1.02%

The Companies also state that the average historical payments that will be in place effective May 1, 2025 are as follows:

Any person interested in commenting on this matter may submit written comments no later than 5:00 p.m. on **Monday, April 14, 2025**. If, however, a member of the public is unable to send written comments by email, a paper copy may be sent to Mark D. Any person who desires to participate in the evidentiary phase of this proceeding shall file a petition for leave to intervene no later than 5:00 p.m. on **Monday, April 14, 2025**. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 CMR 1.03. Receipt by the Department constitutes filing and determines whether a petition is timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.101(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10. All responses to petitions for leave to intervene must be filed by the close of business (5:00 p.m.) on the second business day after the petition for leave to intervene was filed.

All written comments or other documents must be submitted to the Department in **.pdf format** by e-mail attachment to dpu.efiling@mass.gov and alexa.wright@mass.gov. In addition, all written comments should be emailed to the Companies' attorney Joseph Dorfler, Esq., at jdorfler@richmaylaw.com. The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 25-POR-01); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. The email must also include the name, title, and telephone number of a person to contact in the event of questions about this filing. The electronic file name should identify the document but should not exceed 50 characters in length. Importantly, all large files submitted must be broken down into electronic files that do not exceed 20 MB. All documents submitted in electronic format will be posted on the Department's website through our online File Room as soon as
