## NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 25-GSEP-03 November 14, 2025

Petition of Boston Gas Company d/b/a National Grid for Approval of its 2026 Gas System Enhancement Plan, pursuant to G.L. c. 164, § 145, for rates effective May 1, 2026.

On October 31, 2025, Boston Gas Company d/b/a National Grid ("National Grid" or "Company") submitted to the Department of Public Utilities ("Department") its 2026 gas system enhancement plan ("GSEP") to address aging natural gas pipeline infrastructure. The Company proposes to collect \$241,156,523 for the Boston Gas Division and \$18,146,996 for the former Colonial Gas Company ("Colonial Gas Division") through the gas system enhancement adjustment factors ("GSEAFs"). The Company states that the proposed revenue requirement for the Boston Gas Division exceeds the 2.5 percent cap by \$24,087,876 and therefore proposes to defer this amount for future recovery. The Company states that the proposed revenue requirement for the Colonial Gas Division does not exceed the 2.5 percent cap. According to the Company, its proposed 2026 GSEP is consistent with the requirements of G.L. c. 164, § 145, which allows gas distribution companies to accelerate the replacement of eligible infrastructure to improve public safety or infrastructure reliability and to reduce or potentially reduce lost and unaccounted for natural gas. The Department has docketed this matter as D.P.U. 25-GSEP-03.

For the Boston Gas Division, approval of the GSEAFs will result in a monthly bill increase of \$5.50 or 2.0 percent for the average residential heating customer using 106 therms per month during winter months, and a monthly bill increase of \$1.17 or 2.6 percent for the average residential heating customer using 22 therms per month during summer months. For the Colonial Gas Division, approval of the GSEAFs will result in a monthly bill increase of \$0.60 or 0.2 percent for the average residential heating customer using 106 therms per month during winter months, and a monthly bill increase of \$0.13 or 0.3 percent for the average residential heating customer using 22 therms per month during summer months. Pursuant to G.L. c. 164, § 145, on May 1, 2027, the Company will submit to the Department the amount recovered through the GSEAFs for reconciliation with actual 2026 calendar year GSEP costs.

The Company proposes, for the Boston Gas Division, the following GSEAFs by rate class sector for effect May 1, 2026:

In NSTAR Gas Company, 24-GSEP-03, at 55 (April 30, 2025), the Department established a GSEP Risk Assessment Working Group to facilitate the development of a comprehensive risk-prioritization strategy and to improve the transparency and consistency of risk prioritization within GSEP filings. From May 2025 through August 2025, the GSEP Risk Assessment Working Group, led by our Pipeline Safety Division, convened technical sessions to develop proposed risk-based prioritization principles. On September 26, 2025, the Department issued GSEP Risk Prioritization Safety Guidelines ("Guidelines") reflecting the Pipeline Safety Division's recommendations based on its analysis of current LDC processes, as well as stakeholder feedback, and noted that the Guidelines would be officially adopted in a staged process with further investigation being done as part of the LDCs' 2026 GSEPs. The Department will continue its inquiry into the Guidelines in the 2026 GSEP proceedings, D.P.U. 25-GSEP-01 through D.P.U. 25-GSEP-06.

Any person who desires to participate otherwise in the evidentiary phase of this proceeding shall file a petition for leave to intervene no later than 5:00 p.m. on **Monday, November 24, 2025**. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 CMR 1.03. Receipt by the Department constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.01(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10. All responses to petitions to intervene must be filed by the close of business (5:00 p.m.) on the <u>second</u> business day after the petition to intervene was filed.

The Attorney General of the Commonwealth of Massachusetts ("Attorney General") filed a notice to intervene in this matter pursuant to G.L. c. 12, § 11E. Further, pursuant to G.L. c. 12, § 11E(b), the Attorney General filed a notice of intent to retain experts and consultants to assist her investigation of the Company's filing and has requested Department approval to spend up to \$150,000 in this regard. Pursuant to G.L. c. 12, § 11E(b), the costs incurred by the Attorney General relative to her retention of experts and consultants may be recovered in the Company's rates. Any person who desires to comment on the Attorney General's notice of intent to retain experts and consultants may submit written comments to the Department not later than the close of business (5:00 p.m.) on **Monday**, **November 24, 2025**.
