NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 26-SQ-12

March 17, 2026

Investigation by the Department of Public Utilities into Nantucket Electric Company d/b/a National Grid's 2025 Service Quality Report filed pursuant to Service Quality Standards for Electric Distribution Companies and Local Gas Distribution Companies, D.P.U. 12-120-D (2015).

On February 27, 2026, Nantucket Electric Company d/b/a National Grid's ("Company") filed with the Department of Public Utilities ("Department") the Company's 2025 service quality report ("2025 SQ Report") for the period January 1, 2025 through December 31, 2025. The Company's 2025 SQ Report compares its performance during 2025 with the Department's service quality guidelines set forth in Service Quality Standards for Electric Distribution Companies and Local Gas Distribution Companies, D.P.U. 12-120-D (2015) ("SQ Guidelines"), and the Company's service quality plan that the Department approved in Massachusetts Electric Company and Nantucket Electric Company, D.P.U. 16-88 (2017). Per the SQ Guidelines, electric distribution companies may be subject to penalties for failure to meet the Department's SQ performance standards for: System Average Interruptions Duration Index ("SAIDI"); System Average Interruptions Frequency Index ("SAIFI"); Circuit Average Interruptions Duration Index ("CKAIDI"); Circuit Average Interruptions Frequency Index ("CKAIFI"); Customer Complaints; and Customer Credit Cases. The Department has docketed this matter as D.P.U. 26-SQ-12.

The Department will accept written comments on the Company's 2025 SQ Report. Any person interested in commenting on this matter may submit written comments no later than the close of business (5:00 p.m.) on **June 9, 2026**. Please note that in the interest of transparency any comments will be posted to our website as received and without redacting personal information, such as addresses, telephone numbers, or email addresses. As such, consider the extent of information you wish to share when submitting comments. The Department strongly encourages public comments to be submitted by email. If, however, a member of the public is unable to send written comments by email, a paper copy may be sent to Peter Ray Secretary, Department of Public Utilities, One South Station, Boston, Massachusetts, 02110.

All documents must be submitted to the Department in electronic format by e-mail attachment to dpu.efiling@mass.gov and Connor.McElroy@mass.gov. In addition, one copy of all written comments should be emailed to the Company's attorney, Bonnie Raffetto, Esq. at Bonnie.Raffetto@nationalgrid.com. The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 26-SQ-12); (2) the name of the person or company submitting the

filing; and (3) a brief descriptive title of the document. The Company's filing and all subsequent related documents, pleadings and/or filings submitted to the Department and/or issued by the Department will be available on the Department's website as soon as is practicable at <https://eeaonline.eea.state.ma.us/DPU/Fileroom/dockets/bynumber> (insert 26-SQ-12).
