TO APPLY

1. Refer to www.ahridirectory.org to determine if your equipment meets the program requirements. Equipment must be installed by a qualified heating contractor or plumber.
2. Complete the energy efficiency rebate application online at <https://www.amplifyincentives.com/NationalGridNYGas/> and upload your paid contractor receipt/invoice — it's that easy. For help with portal access, call **1-877-888-3024**.
3. This program is available for installs completed between 1/1/2023 and 12/31/2023. Applications must be submitted online within 60 days of installation but no later than 12/31/2023.

PROGRAM DETAILS

Due to limited funding, the program may be terminated at any time. New York City rebate offers are available to residential customers that reside in Queens, Brooklyn, and Staten Island where natural gas is available. Long Island rebate offers are available to residential customers who reside in Nassau/Suffolk counties and the Rockaway Peninsula where natural gas is available. National Grid high-efficiency equipment rebates are available for both existing natural gas heating and oil-to-gas conversion customers of National Grid regardless of equipment manufacturer.
