If you're a new applicant for the Income Eligible Energy Services Program, you'll need to apply in person at your local Community Action Program (CAP) agency.

Call your local CAP agency, listed on the back of this brochure, for more information.

Energy saving services are available if your home is heated with:

- Gas
- Electricity
- Oil
- Propane
- Wood

You can qualify as:

- A homeowner
- A renter
- The landlord of a 1- to 4-unit building in which at least half of the residents meet income eligibility requirements

If you live in a building with 5+ units in which at least half of the residents meet income eligibility requirements, you may be eligible to be served by our multifamily program. Please have your landlord or condo association call **1-888-633-7947** to learn more.

Easy energy saving tips



Close shades and drapes at night to keep heat in during the winter.



Replace old-fashioned incandescent light bulbs with LED bulbs.



Use pot lids when cooking on the stove; food will cook faster.



Run the dishwasher only when it's full.



Turn off computers, monitors, stereos, radios, and TVs when not in use.



Set thermostats to 78° in summer, 68° in winter.

Discover No-Cost Home Energy Improvements

See if you qualify for our Income Eligible Energy Services Program.



Our **Income Eligible Energy Services Program** is designed to help make sure you can enjoy a more energy-efficient home that's healthier, more comfortable, and more affordable for you and your family.

How the program works

Once you qualify, your local **Community Action Program (CAP) agency will arrange a time when an Energy Specialist can visit your home to complete a no-cost home energy assessment.**

The Energy Specialist will look inside and out, from attic to basement, to find places where you can save energy and money.

You may also qualify for no-cost energy saving improvements, such as:



A no-cost replacement of your heating system



A no-cost replacement refrigerator, freezer, clothes washer, dehumidifier, and/or window A/C unit if your current appliance is inefficient



No-cost energy saving services including attic and wall insulation, weather-stripping, and air sealing of leaks



No-cost installation of energy-efficient lighting and water saving devices

Does my household qualify for no-cost energy efficiency services?

Use the chart below to see if your household meets the income requirement for the **Income Eligible Energy Services Program** as well as other energy services, such as **Fuel Assistance** and **discount fuel rates**.
