National Grid \$10,000 BMW i3 Purchase Incentive Program

FAQs

As part of the effort to accelerate clean transportation alternatives, BMW is offering eligible customers of National Grid in New York a special incentive of \$10,000 off best negotiated price on the purchase of a new i3 or i3s BEV (all electric) or REx (electric with range extender).

1. Who is eligible for the \$10,000 i3 purchase incentive?

Customers of National Grid in New York and their immediate family members living at the same address are eligible if they reside at the same address as the customer. Proof of residency needs to be provided along with the customer's National Grid utility bill.

2. What must I provide to the dealership to receive the \$10,000 i3 purchase incentive?

Eligible participants must provide a copy of a completed Customer Information Form and a copy of a recent National Grid utility bill to receive the offer.

3. Where can I locate the official Customer Information Form?

4. What vehicles are included in the \$10,000 i3 purchase incentive?

The purchase incentive includes all current model years of new BMW i3 models, including the i3 BEV, i3s BEV, i3 REx, and i3s REx. No other models are eligible for this offer.

5. Can I use the \$10,000 i3 purchase incentive with models other than the i3?

No, this incentive is for a new i3 or i3s (=i3 Sport).

6. Can the \$10,000 i3 purchase incentive be applied on a lease transaction?

No, this incentive is only valid for purchase or finance of the i3 or i3s (BEV and REx models).

7. Can the \$10,000 i3 purchase incentive be applied on a certified pre-owned or used BMW i3?

No, this incentive is only applicable to the purchase of a NEW i3 or i3s.

8. Is the \$10,000 i3 purchase incentive applied at the time of transaction?

Yes, the incentive is applied at the time of sale and will be deducted from the purchase price.

9. Can the i3 purchase incentive be combined with other retail promotions?

No, this incentive cannot be combined with other offers or retail promotions.

10. Is the i3 purchase incentive only applicable to current inventory?

No, this incentive can be applied to current inventory AND orders placed through July 31, 2018.

11. When does this program expire?

This offer is valid through July 31, 2018.

12. Which BMW dealerships are participating in this program?

The offer is good at any authorized BMW dealership.

13. I just purchased an i3 - can I still get the \$10,000 i3 purchase incentive for my car?

The purchase incentive is applicable only to new purchases made during the offer time frame of April 1 - July 31, 2018.

14. Can eligible participants purchase more than one i3 during the program?

Yes. A National Grid customer (residential or commercial) can purchase one or more i3. The \$10,000 purchase incentive will be applied to each purchase.

15. How many miles can you drive the i3 on a single charge?

The EPA-estimated total ranges for the i3 models are:

- 114 miles for the i3 BEV
- 107 miles for the i3s BEV
- 180 miles for the i3 REx and i3s REx

16. What does i3 REx mean?

REx stands for range extender. The extender is a small gas fueled engine that maintains the state of charge when the battery level is low, thereby extending the total range of the i3 to 180 miles. The range extender does not power the wheels or actively recharge the battery.

17. Do I need special equipment to charge the i3?

Every i3 comes with an occasional use cable that can plug into a standard 120V outlet. However, there are charging solutions available that reduce the charging time of your i3. Please talk to your local BMW dealer for details or go to **www.bmwcharging.com**.

18. How can I find out where EV chargers are located?

EV drivers can find lists of thousands of public use charging stations available to them through websites such as the U.S. Department of Energy website at **www.afdc.energy.gov/fuels/electricity_locations.html**.

19. Is public charging free of charge?

It depends. Some public stations do not charge a fee for charging. Furthermore, new BMW i3 owners qualify for 24 months of free charging at EVgo charge points (30 minutes of free DC fast charging per session or 1 hour of free Level 2 charging per session). See **www.chargenowusa.com** for details.

20. How are these purchase incentives funded?

The purchase incentive is funded through BMW of North America.

21. How do I receive a \$7,500 federal electric vehicle tax incentive?

The federal tax credit is applied when filing for taxes and applied against income tax owed. Customers are encouraged to contact tax professionals to better understand how it applies to their tax situation.
