TO BE ELIGIBLE FOR THE OFFER:

- Eligible ENERGY STAR® certified clothes dryer must be installed within the Rhode Island electric service area of Rhode Island Energy.

- A copy of your receipt showing the manufacturer name, complete model number[†], purchase date, purchase price and store name

[†] If the model number is not included on your receipt, please provide alternate documentation. We will accept a photocopy of the appliance manual cover with the model number you purchased circled. Alternatively, we will accept a Home Depot special services customer invoice (generally provided to you by the appliance department).
